A RESOLUTION OF THE CITY OF WASHINGTON, COUNTY OF WASHINGTON, COMMONWEALTH OF PENNSYLVANIA ADOPTING THE WASHINGTON / EAST WASHINGTON MULTI-MUNICIPAL COMPREHENSIVE PLAN, DATED THIS 8th DAY OF Dec., 2011 AS PREPARED BY THE WASHINGTON / EAST WASHINGTON COMPREHENSIVE PLAN STEERING COMMITTEE, AND FACILITATED BY MACKIN ENGINEERING COMPANY, PURSUANT TO ARTICLE III AND ARTICLE XI OF THE PENNSYLVANIA MUNICIPALITIES PLANNING CODE.

Whereas, a copy of the comprehensive plan, which includes the text, maps, charts and any other items which form the whole of the comprehensive plan and was made available for public review at City Hall is attached hereto as exhibit "A"; and,

Whereas, the Washington / East Washington Multi-Municipal Comprehensive Plan was sent to all contiguous municipalities, the Washington School District, and the Washington County Planning Commission for review and comment on October 24, 2011; and,

Whereas, the City of Washington has received no substantial comments from the contiguous municipalities, the Washington School District, and the Washington County Planning Commission within forty-five (45) days of submission of the Washington / East Washington Multi-Municipal Comprehensive Plan; and,

Whereas, notice of a public hearing was forwarded to the Observer Reporter newspaper to be advertised and published on November 25, 2011 and November 30, 2011; and,

Whereas, City Council held a public hearing on Thursday, December 8, 2011 to hear and consider public comments, and that the comments received at the public hearing were duly noted; and,

Whereas, City Council, after consideration of comments received (or lack thereof, as the case may be), has determined that the Washington / East Washington Multi-Municipal Comprehensive Plan, as originally set forth in Exhibit "A", should not be substantially revised in whole or in part; and,

Whereas, Council has found the comprehensive plan is beneficial to the health, safety and welfare of the citizens of the City.



Whereas, notice of the public hearing was advertised and published in the Observer-Reporter newspaper on December 1, 2011 and December 5, 2011; and,

Whereas, Borough Council, after considering comments received, has determined that the Comprehensive Plan, as originally set forth in Exhibit "A", should not be substantially revised in whole or in part; and,

Whereas, Council has determined that the Comprehensive Plan is beneficial to the health, safety and welfare of the residents of the Borough,

NOW, THEREFORE, BE IT RESOLVED BY COUNCIL OF THE BOROUGH OF EAST WASHINGTON, AND IT IS HEREBY RESOLVED AND ENACTED BY THE AUTHORITY OF THE SAME:




