## ***TERMS FOR BOROUGH OF EAST WASHINGTON PAVILION POLICY***

- 1. No alcohol!***
- 2. Pavilion rented to adults...21 years or older.**
- 3. There shall be no public meetings or assemblages in the Park without permit.**
- 4. No grilling. No open fires in the park or pavilion area are permitted.**
- 5. Only tape may be used to secure tablecloths and wall decorations. All signage or decorations must be removed at the end of the rental period or the damage deposit may be withheld.**
- 6. Defacing or damaging the pavilion or park area is strictly prohibited and will be enforced under the fullest penalty of the law.**
- 7. Electric amplification equipment is prohibited.**
- 8. No dogs, cats or other domestic animals at any time.**
- 9. Petting zoos or any special event must be accompanied by a Certificate of Insurance in the amount of \$500,000.00 naming the Borough of East Washington as co-insured.**
- 10. There shall be no firearms or archery equipment permitted in the park area.**
- 11. No fireworks of any kind.**
- 12. Picnics shall be held only in designated locations and all picnickers shall be responsible for cleaning up the picnic areas and to place all waste in appropriate containers.**
- 13. No persons shall operate any vehicle in excess of 10 miles-per-hour.**

14. No parking is permitted in unauthorized areas.
15. No mini-bikes, quads, trail bikes or motorcycles are permitted to be operated within the park boundaries.
16. Trees, shrubs and grass shall not be damaged in any way.
17. Goods, merchandise and services shall not be sold or leased in the park area without a permit.
18. Park closes at dusk.
19. Adult supervision by the renter of all children in attendance is required.
20. The Borough of East Washington reserves the right to expel any renter from the park and/or pavilion area if the Rules and Regulations of the Park are violated. Also, a full forfeiture of the damage fee will occur.
21. No admission fee may be collected on the premises without permission of The Borough of East Washington.
22. Provisions such as tents, extra tables and chairs must be approved by the Borough of East Washington.
23. East Washington Borough reserves the right to photograph during events for promotional purposes.
24. The Borough of East Washington reserves the right to amend these policies at any time. The renter shall be bound by the Policies in effect at the time of the event.
